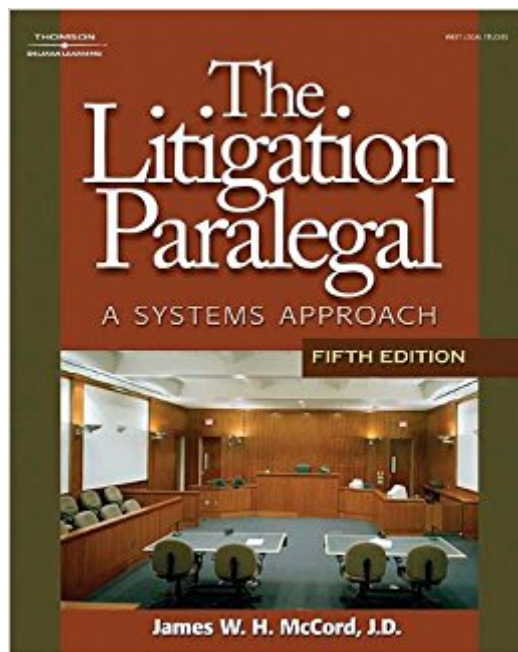

James McCord is an experienced trial attorney in criminal law, professor at the University of Wisconsin Law School, and a member of the Wisconsin and Kentucky Bar Associations. A frequent speaker at legal conferences, he is the author of several books and articles on the paralegal profession and practice. Professor McCord is a past president of the American Association for Paralegal Education, a former member of the American Bar Association Legal Assistant Program Approval Commission, and included in "Who's Who in Law."

The bare complete basics of what a Paralegal can and cannot do is in this book. In addition, it supplies sample documents, basic checklists for initial interviews, evidence and discovery, and trial preparation. Everything is simplified and easy to locate by scanning the Table Of Contents, unlike

most text books that reference and cross-reference everything in confusing categories. This is the 5th edition, so I'm expecting future editions that update forms to conform to changing laws. I highly recommend it for students in the profession even if it's not in your syllabus.

I'm using this for a class right now. It was the least expensive option I found. I have downloaded the kindle reader on my iPad mini and use that in place of a bulky book when I attend. I can pull it up on any PC (after downloading the Kindle reader) and it remembers my highlights and bookmarks. I can always pick up where I left off on any device. I love this option and it should be a serious consideration for all students.

This book has a lot of sample . templates that are really good to reference. They tend to be federal examples though, but that's probably because federal is the same everywhere. Lots of amazing information presented in simple wording so it doesn't get too confusing like a lot of other law books. And despite the title, it's actually a pretty interesting, engaging book!
