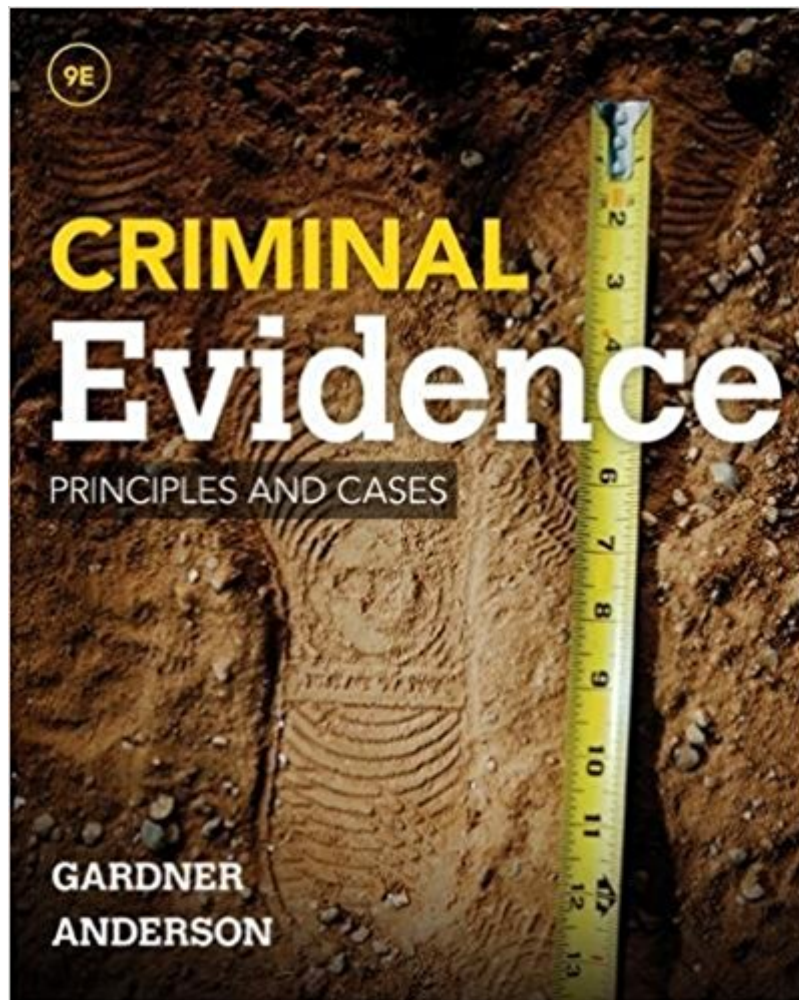

Gardner is a proven author and widely respected practicing attorney with more than fifty years of experience, including several years as an assistant district attorney in Milwaukee, Wisconsin. Mr. Gardner received his law degree from Marquette Law School. Terry M. Anderson is Professor of Law at Creighton University School of Law. He received his Bachelor of Arts degree in 1968 and Juris Doctor degree in 1971 from the University of North Dakota, where he was a member of the Order of the Coif and Case Editor of the North Dakota Law Review. After earning a Master of Laws degree from Harvard Law School in 1972, he joined the Creighton law faculty. He has been a visiting Professor at the University of New Mexico School of Law, and the Denver University School of Law. He teaches Criminal Law, Contracts, and Secured Transactions in Personal Property.

This is the 2nd Criminal Evidence book that I've utilized by Gardner and I must admit, this, as with the previous edition, are great books. It provides lots of clear details thereby allowing me to gain a quick understanding of the normally difficult concepts. I would recommend this book to any

I read the text as a required reading for a legal course in the Fraud and Forensic Science master's program at Carlow University. Prior to reading the text, the extent of my legal knowledge came from a few general business law courses taken in undergraduate school many moons ago. I found this particular text very easy to follow. The authors manage to pack in a great deal of significant information, rules, codes and laws pertinent to criminal evidence without being overbearing. The cases added throughout the chapters help put the laws into a realistic perspective; giving several examples of how the rule/law came to be and how it is used in current legal situations. Overall, the text was presented in a manageable format that would benefit a novelist or someone experienced in the legal field.

This was a required book for my criminal evidence class so I was thrilled to find it on used for 75% less than my college bookstore store. The book arrived in excellent condition with no rips or tears but had some highlighting on only a few pages. The book itself is a easy read, the author does a great job of going over basic rules of evidence. There is a recap at the end of every chapter and questions with answers to help with studying. Not to mention this book did not hold back on discussing every possible type of evidence, such as, wiretapping, hearsay, child witnesses, lineups, and fingerprints, to name a few. Additionally, the layout of the chapters were easy to follow through the criminal and investigation process. I now have a much clearer understanding of the acceptable practices of investigating, gathering, handling, and presenting evidence for the best outcome in a trial. However, the only drawback to this book, is that some of the

information can become boring.

Gardner and Anderson's book, *Criminal Evidence Principles and Cases*, was a required text in my graduate program. I am pursuing a Master's of Science degree in the field of Fraud and Forensics from Carlow University. Being a non criminology major or law enforcement professional, I was not up-to-date on the laws regarding Rules of Evidence, what constitutes a lawful search, court room proceedings, etc. Gardner and Anderson does an excellent job in braking down the legal jargon to give the student a simple but strong understanding. After reading this book I can say with confidence I have a greater understanding of the Fourth, Fifth, and Sixth Amendments of the U.S. Constitution.
